HISTORY OF INTERSTATE PASSPORT®

To understand how Interstate Passport® came to be, we must introduce two affinity groups within WICHE's Programs and Services Unit. The Western Academic Leadership Forum (Forum, formerly WALF), is a membership organization formed in 1987 that serves as a collaborative network to exchange ideas and information. share resources and expertise among provosts, academic vice presidents, chief executives, and chief academic officers at WICHE-region public and private doctoral, master's, and bachelor's level institutions and related systems offices and state agencies. In fall 2009, a motion was proposed to assess interest and initiate a similar organization to serve community colleges and technical schools, their associated systems offices and state agencies.

In 2010, the Forum granted \$10,000 in seed funding to a group of academic leaders from two-year institutions to form what would become the Western Alliance of Community College Academic Leaders (Alliance, formerly WACCAL). One of the first issues raised among these leaders was the topic of transfer. These academic leaders, inspired by the American Association of Colleges and Universities (AAC&U) Liberal Education & America's Promise (LEAP) learning outcomes (now called Essential Learning Outcomes or ELO), proposed the idea of transfer based on learning outcomes rather than credit hours.

Guiding Principles

STUDENT-FOCUSED

The Interstate Passport® program was developed with the student at the center of the transfer experience. Traditional transfer costs students dearly in time, money, and motivation. By guaranteeing a block-transfer of lower-division general education credits, Interstate Passport® allowed students to focus on their long-term goals without the burden of navigating multiple schools' requirements.

FACULTY-DRIVEN

The 63 Passport Learning Outcomes (PLOs) that made up a student's passport were negotiated and agreed upon by interstate faculty teams. Rather than prescribing Interstate Passport® requirements, faculty at Passport institutions determined that their school's lower-division general education learning outcomes were consistent with the goals of the agreed-upon PLOs. Interstate Passport® relied on faculty governance and assessments to establish methods for students to demonstrate proficiency in the desired learning outcomes.

In October 2011, the Interstate Passport®
Initiative was launched as a regional project of
WICHE to address the problems of interstate
transfer. The two- year pilot project (referred
to as Phase I) was funded by the Carnegie
Corporation of New York to engage participants
from California, Hawai'i, North Dakota, Oregon,
and Utah. During the pilot phase, faculty from
the targeted institutions collaborated to develop
the Passport Learning Outcomes (PLOs) and
Proficiency Criteria, using ELOs (formerly LEAP
outcomes) as a foundation, and referencing each
state's own lower-division general education core
learning outcomes.

Registrars and institutional research representatives developed the processes for recording the Passport on student records, and for tracking and reporting on Passport students at both sending and receiving institutions. At the end of the pilot phase, 16 two- and fouryear institutions from four pilot states (Hawai'i, North Dakota, Oregon, and Utah) forged a general education transfer agreement – the Passport – in the core content areas of oral communication, written communication, and quantitative reasoning. The two institutions from California, California State University Sacramento and Sacramento City College, decided not to enter into the Passport agreement for Phase I because the Passport did not include critical thinking. This content area would be included in Passport Phase II.

Institutional Autonomy

The Interstate Passport® program was unique in its ability to honor the distinct methods and values of different institutions and their ability to produce standardized learning outcomes. Rather than demanding standardization, Interstate Passport® acknowledged that the curriculum and academic programs vary among institutions. This does not compromise the desired outcomes for students across all institutions, nor did Interstate Passport® require the member institutions to change the language or goals of their existing general education requirements.

QUALITY ASSURANCE

An essential component of Interstate Passport® was the data collection and tracking process designed to provide information on the academic performance of Passport earners for use in continuous improvement efforts by member institutions and for evaluation of the overall effectiveness of the program. Registrars and institutional researchers were key players in designing and implementing this process, as well as utilizing the National Student Clearinghouse (NSC) as the central data repository for the program.

With these processes and infrastructure in place, project leaders planned a second phase that focused on two objectives: 1) to encourage other WICHE states and institutions to apply for Passport status in the Phase I content areas, and 2) to develop outcomes and proficiency criteria, based on the ELOs, for the remaining general education core content areas (creative arts, intercultural knowledge/social sciences, information literacy, natural and physical sciences, critical thinking, and teamwork/problem-solving).

As part of the pilot phase, the project plan called for research and analysis. Project staff reviewed state statutes and regulations and solicited information from institutions in the WICHE region on general education and transfer and block transfer agreements, both in state and across state to produce two reports; *General Education Policies in the WICHE States* (2012) and *Overview of State Policies on Lower-Division General Education Core in the WICHE States* (2012). In addition, data from the NSC on student transfer for the fall 2006 cohort of public institutions in

the WICHE region provided information about the transfer patterns of students both within WICHE states and across state lines for the report <u>Student Transfer Patterns in the WICHE</u> <u>States: A Look at the Fall 2006 Cohort</u> (2016).

In 2014, with support from the Bill & Melinda Gates Foundation, WICHE produced the Transfer Solutions through Cross-Organization Alignment Summit, a two-stage convening of higher education leaders from a broad spectrum of postsecondary institutions and organizations who gathered to share information and perspectives around some of the complex issues associated with transfer. The result of these convenings produced the <u>Successful Student Transfer: A Key</u> **Building Block of the Completion Agenda** (2014) white paper that provides a high-level overview of the contemporary transfer landscape and how the Interstate Passport® novel block transfer framework could streamline transfer of lower division general education credits. Momentum from these convenings led to Phase II of the Interstate Passport® Initiative.

Phase II of the program's development was funded by the Bill & Melinda Gates Foundation and Lumina Foundation. The grant funds supported development of the PLOs and transfer-level proficiency criteria (PC) in six additional areas (creative arts, intercultural knowledge/social sciences, information literacy, natural and physical sciences, critical thinking, and teamwork/problemsolving); piloting an electronic data collection process through the NSC; and expansion to states/ institutions outside the WICHE region. Perhaps the most significant outcome of Phase II was completion of the full PLO framework consisting of nine lower-division general education areas. Faculty members from seven states collaborated to develop PLOs and PC in the six areas. This work builds on that accomplished by faculty in participating institutions in the Phase I states.

Additional funding from The Bill & Melinda Gates Foundation allowed the Phase II institutions to better prepare for the program's implementation, conduct advising, market, and support staff workshops. Along with the partners within the WICHE region, these funds allowed for stakeholders in six states outside the WICHE region to participate in workshops to develop and refine the initiative (AR, ID, IN, KY, OH, and VA).

In October 2015, WICHE received a fouryear First in the World (FITW) grant from the U.S. Department of Education. The work conducted under the FITW grant encompassed four components:

1) building robust and automated national data collection and transfer student tracking infrastructure in partnership with the NSC, 2) modeling the mapping of critical assignments to PLOs, 3) scaling participation in the Interstate Passport® Network, and 4) researching the impact of Interstate Passport® on transfer students.

Prior to the NSC pilot project (2015-16), the Passport Central Data Repository, hosted and

operated by Utah State University, collection and tracking functions were conducted in the fall of each year, and Passport data was collected manually. The NSC pilot project allowed for the development of PassportVerify and Academic Progress Tracking. Over 45 representatives from six Passport states attended the registrar/IR workshop in February 2016 to discuss in detail the tasks and responsibilities for recording the Passport on student records, tracking Passport students, and submitting data to NSC. This convening produced handbooks for registrars and institutional researchers as well as the Passport Data Management Plan which addressed privacy issues, Family Educational Rights and Privacy Act (FERPA) compliance, and data ownership.

Critical to the research activities of the FITW grant was the development of a six-year longitudinal study of the academic progress of Passport students. Rutger's Education and Employment Research Center (EERC) led the research effort.

In AY 2016-17, six years of planning and execution came to fruition with the launch of the Interstate Passport® Network and the first institutional datasets. During this academic year, the initiative continued to be funded through the FITW grant, the Bill & Melinda Gates Foundation, and Lumina Foundation. The NSC completed development of the data collection and report infrastructure for tracking students who are Passport earners in January 2017. During spring 2017, members of the Advisory Committee for Registrars/Institutional Researchers participated in the testing phase of NSC's Passport Services. Registrars and institutional researchers from 10 institutions. extracted actual data from their student information systems (SISs), or created data for the test phase, and submitted test files to NSC.

All participating institutions received reports on the academic progress of their transfer students after transfer to another Network member institution. Data were supplied by NSC to these institutions, annually, for both native and transfer students, aggregating student-level results by institution, and by "earned Passport" (Y/N). The reports supplied to individual institutions (sending institutions) contain information on student academic progress with the same level of detail

outlined in the bulleted dimensions above. For more information about Academic Progress Tracking, please see the Cumulative Data section of this report (page 60).

During the second year of full implementation of Interstate Passport®, 16 institutions reported to the NSC that students earned 12,975 Passports. During AY 2017-18, the initiative continued to be funded through the FITW grant, the Bill & Melinda Gates Foundation, and Lumina Foundation. AY 2017-18 saw a major push to engage with military and veteran students. As military students are reassigned to new posts throughout the country and attempt to continue their education, too often they must repeat coursework to satisfy general education requirements. The completion— transferability and portability—of general education requirements is one of key factors in students delaying or not completing their degree. In February 2018, Air University, based in Montgomery, AL, joined the Interstate Passport® Network, and WICHE formed a Veteran and Military Affairs Advisory Committee.

From 2016-2018 the five advisory committees: Institution Liaison Advisory Committee, Veteran and Military Affairs Advisory Committee, Academic Advisors Advisory Committee, Marketing Advisory Committee, and Registrar and Institutional Advisory Committee participated in a series of planning and "Trainthe-Trainer" committees to help align institutional teams across the membership and serve as a built-in feedback mechanism for WICHE staff. AY 2017-18 was the final year that WICHE used funding to convene Train-the-Trainer, Passport Review Board, or Interstate Faculty Working Groups in-person, and moved to a conference call-based convening model.

In AY 2018-19, the Interstate Passport® Initiative was funded by the FITW grant and Bill & Melinda Gates Foundation. An external evaluation of the Interstate Passport® program was required as a component of the U.S. Department of Education's FITW grant. Our evaluator was the Education and Employment Research Center (EERC), School of Management and Labor Relations, at Rutgers University. In AY 2018-19 the evaluator moved forward on the study in three states—Hawai'i, South Dakota, and Utah. Data points required for the analysis included student characteristics (age, gender, race/ethnicity, Pell status), academic preparation variables, transfer information (including student movement to and from institutions), and student academic history. The evaluation team began a qualitative study focused on students' intentionality in earning a Passport. Interviews of Passport students began in fall 2019 across member institutions in Utah.

Education Marketing Group (EMG), a nationally recognized leader in higher education marketing, executed a national, multi-platform digital campaign focused on established higher education communications platforms in order to reach, inform, and motivate higher education administrators and decision-makers regarding institutional benefits of Network membership. The campaign began in November 2018 and ran through October 2019. In collaboration with staff, EMG developed creative designs and messages that reinforced the Network brand.

The COVID-19 pandemic coincided with the final year of the U.S. Department of Education's FITW Grant, creating a great urgency around recruitment and retention into the Interstate Passport® Network. In responding to these changing tides, WICHE staff established the Colleagues for Interstate Passport® Future advisory group and issued a Call to Action in July 2020 in response to a renewed sense of urgency during the pandemic, when many students left campus and returned home to finish their studies, to find a more efficient way to advance the access, completion, and equity issues surrounding college transfer. Over 200 supporters signed onto the Call including representatives of Passport Network member and non-member institutions and regional and national higher education organizations and associations. AY2019-20 saw a heroic recruitment of 28 institutions into the network; however, because many of the founding institutions were under five- or ten-year waiver of their dues, no institution was due to start paying membership dues until FY24 creating an even more urgent need to recruit new institutions at a time when institutional labor was stretched thin. A major goal of the Colleagues for Interstate Passport® Future advisory group was to help WICHE staff identify and acquire a new funder for the project.

In AY 2020-21, Interstate Passport® received funding from two sources to support the program.

As a part of the Catalyzing Transfer Initiative, ECMC Foundation provided a two-year grant to enable WICHE staff to recruit and enroll 20 additional member institutions to the network – including at least 10 Minority Serving Institutions (MSIs) – by offering a two-year waiver of membership fees. The National Science Foundation (NSF) awarded WICHE and New Mexico State University (NMSU) in collaboration with its branch community colleges a one-year grant aimed at bringing more undergraduate transfer students majoring in science, technology, engineering, and math (STEM) to graduation and,

ultimately, the job market. The project included testing the feasibility of using sets of lower-division student learning outcomes as the basis of block transfer into undergraduate engineering programs and the production of the <u>STEM Passport Literature Review</u> (2021) which provided information on the landscape of the engineering transfer, barriers to transfer, how institutions are working to improve engineering transfer, and ways to continue the revision of engineering pathways based on learning outcomes.

AY 2021-22 marked the 10th anniversary of the Interstate Passport® Initiative and presented an opportunity for serious reflection. WICHE staff attended the ECMC Foundation's in-person Catalyzing Transfer Initiative in September 2022 for reflection and idea-generation among the community of practice. WICHE and NMSU utilized a one-year capacity-building grant from NSF to conceptualize a STEM Passport in electrical engineering. Though generous funding from ECMC Foundation allowed for inclusion of new institutions into the network, WICHE staff reported a trend of some of the institutions electing not to renew their MOU with the network, stagnation in reporting numbers, and challenges with capacity and turnover at new institutions leading some to have challenges in completing their block and set up their reporting mechanisms before the end of their two-year waiver period.

In August 2022, WICHE staff partnered with an outside consulting firm, Philosophy Communications, to convene focus groups of current and prospective members to get feedback on the Interstate Passport® program, evaluate messaging strategies, and better understand the perception of the program. The feedback that WICHE staff received about the Interstate Passport® program from current members was that the implementation process was successful, complex, and powerful, but it's unclear if the program was a "success" at their institution. Three overarching questions for

participants included: are our students using this program to transfer? Are transfer student success outcomes improved? Does implementing Interstate Passport® at their institution gain member institutions students? The feedback that WICHE staff received about the Interstate Passport® from prospective members is that the impression of the program was generally very good, but there was little urgency to engage with the program. With existing articulation agreements between institutions and state-wide general education transfer mandates, Interstate Passport® did not make a value proposition that felt like it was filling an urgently needed void in their transfer strategy. Existing and prospective members both expressed that they wanted more data to prove the success of the program before making further investments. Due to inconsistencies in reporting, there was insufficient data from Academic Progress Tracking (APT) to give institutions the powerful metrics they asked for.

Individuals in these focus groups also reported frustration with the technology implementation of the outward-facing member portal for advertising resources to students and reported difficulties in updating and maintaining the cold-fusion website where the institution Passport Blocks were maintained. To that end, WICHE staff sought and were awarded a one-year technology capacity grant of \$435,000 from an anonymous funder to improve the technological infrastructure of the Interstate Passport® program.

Academic Year 2022-23 marked the end of the ECMC Foundation grant period and the conclusion of the NSF-funded STEM Passport Pilot. In March 2023, WICHE staff convened the governing body for Interstate Passport®, the Passport Review Board, to solicit feedback about the budget and growth capacity of the program.

The program's long-term financial viability was a primary concern for the Passport Review Board; all current Interstate Passport® Network members had joined under a membership fee waiver, and the Network had never collected dues throughout the program's life.

Throughout April and May 2023, WICHE staff polled Institution Liaisons to determine the interest in financially supporting the program's continuation at their institutions and shared the results with the Passport Review Board. With no program options or enhancements that retained enough membership to sustain operations financially, combined with feedback that the labor required of institutional staff to administer the program and comply with data reporting was too burdensome, the decision was made to cease recruitment into the Network and allocate resources toward building a free online resource center with materials based on the lessons learned from Interstate Passport®." Throughout AY 2023-24, WICHE staff has migrated Passport Blocks and collateral around the PLOs to a resource center on the WICHF website. In fall 2023, WICHE staff convened an Articulation Working Group to produce a template document that could be leveraged by former Interstate Passport® Network institutions to maintain transfer pathways established by the original Interstate Passport® Network. The document, along with the **Passport Learning Outcome** worksheets and matrices, can also provide a framework for any institution interested in learning outcome-based transfer.

Even as the Interstate Passport® Network sunset the program, the \$435,000 technology implementation grant that was awarded for academic year 2022-23 remained. Rather than return the funds, WICHE staff developed a new project called the Technology Partnerships

for Transfer Success initiative and received permission to pivot funding from Interstate Passport® and subgrant funds to institutional partners in the WICHE region with the goal of supporting hands-on transfer advising and transfer assistance through the development and implementation of technology solutions that provide targeted and real-time information to transfer advisors and students, to increase the rates at which transfer students successfully proceed through major coursework, and towards completion. In February 2024, WICHE staff opened a call for proposals from which six projects across thirteen institutions were selected. This project will conclude in fall 2026 with WICHE sharing outcomes from each of the five projects.

There is an ongoing need for innovation, improvement, and the removal of impediments to successful student transfer. WICHE continues to hear ongoing demand for resources and information to continue work towards transfer innovation. The complexities of transfer remain a perennial issue despite recent progress on articulating credit, in no small part because students attempting to transfer represent the 'messy reality' that students need flexible on-andoff-ramp opportunities for getting postsecondary education while they progress through life, while at the same time, institutions need to ensure quality and be able to operate at scale. WICHE is incredibly proud and grateful for the ten years of innovation, ideation, and development of the Interstate Passport® program, an idea which has undoubtedly influenced the way institutions approach transfer. The work that WICHE continues to do in areas of transfer, credit mobility, and large-scale implementation of initiatives will forever be shaped by the Interstate Passport® initiative and the work of the hundreds of stakeholders that brought it to fruition.

CUMULATIVE DATA

Beginning in AY 2016-17 WICHE has received two annual reports provided by the National Student Clearinghouse (NSC) that aggregate student-level data submitted by Network members for each academic year through 2022-23. The Passport Review Board (PRB), as the policymaking body, reviewed these reports to ensure that the Passport Network was providing expected benefits to students and that member institutions are meeting expectations.

These reports are:

- Total Number of Passports
 Awarded in the Academic Year
- Academic Progress Tracking of Passport Earners

The first report is a simple summary of annual Passport awards organized by state, institution, and institution type (2-year vs. 4-year). This report is organized by state and institution, and by award semester (quarterly results are regularized into semester format by the NSC as part of the data submission process). The second report tracks students with a Passport who transferred to a Network member institution. It compares the academic progress of students who transferred with a Passport to two groups: a) students without a Passport who transferred from one Network institution to another; and b) students who earned a Passport at the reporting institution but did not transfer. The academic progress tracking report aggregates data from all receiving institutions across nine dimensions for at least two terms after transfer and records

all graduations that occur in that reporting period. The expectation of the WICHE Passport program was that students transferring with a Passport would perform (in aggregate) better (in terms of GPA and credits earned) than students transferring without a Passport, and that they would perform at least as well as those students who originate at the home institution who earn a Passport but do not transfer.

Academic progress tracking was designed to ensure the overall quality of the Interstate Passport® program. Interstate Passport® Network members agreed to send information about students that transfer into their institutions with and without a Passport to the NSC. Tracking was provided for at least two terms after transfer. Members also reported the academic progress for the students who earned a Passport at their institution and continue their studies there for at least two terms after earning it for comparison purposes.

Data Collected. To ensure student confidentiality, the data submitted by "receiving" institutions (those schools that receive Passport transfer students) were de-identified. This also ensures that more students were included, providing a more representative sample of the transfer population. The institution submitting the data assigned an auto-generated number to each student so that the number could be used by NSC to tie the performance of that student from one term to the next, but only the institution assigning the number knew to which student a number belonged. At the end of each term, participating

institutions uploaded student and course-level data to NSC.

The following characteristics were collected.

Student Characteristics:

- Race/Ethnicity
- Gender (Male/Female)
- Age
- Low Income (Pell Eligible as proxy)
- Military Veteran
- ► First-Generation Student (Y/N)
- Degree Level (Associate's, Bachelor's)
- GPA Earned Before Transfer
- ► Total Credits Earned Before Transfer

Course-Level Characteristics:

- Number of Credits
- Grade by Student

NSC Calculated Statistics


- Average GPA
- Average Number of Credits
- Count of Students Graduated

This reporting was developed with feedback from institutional researchers and registrars at 24 institutions across the West to give the best possible quality assurance and impact tracking. In partnership with the NSC, workshops, webinars, and collateral were developed to support the recording and reporting requirements of Interstate Passport® at each participating institution. WICHE allocated budget for registrar consultants to be available to new institutions. Despite these efforts to make the reporting

process coherent, there was a persistent lag in reporting institutions, particularly for the academic progress tracking report. Many institutions, particularly from 2020-2023, reported issues in staffing capacity and persistent errors in submitting files that required many staff hours in troubleshooting. As a result of this lag, it is impossible to know the true scope and impact of the Interstate Passport® program.

Within our limited scope of academic progress tracking, there were consistent trends that could be seen year over year. Average GPA for Passport transfers remained similar over the tracked years. In addition, the pattern of results; students transferring with a Passport earning a higher average GPA than non-Passport transfers in the terms immediately post-transfer and earning similar GPA to students who earn a Passport and remain at their home institution, remained consistent across all reported dimensions. GPA for Passport transfer students (after transfer) was consistently higher when compared to students who transferred without a Passport in the same cohorts, irrespective of Race/Ethnicity, Gender, Age, Low Income (Pell), Military Veteran, or First-Generation Student status, for all measurable sub-groups with significant sample size.

Because of the smaller sample sizes, the results by IPEDS Race/Ethnicity categories are more difficult to interpret (the samples for many race categories were too small to draw any statistical inferences). The overall trends (Passport transfers perform better than non-Passport transfers, and similar to Passport earners who remained at the same institution) remain generally consistent. In no race/ethnicity subcategory did Passport transfers have a lower GPA than non-Passport transfers, and in a few race/ethnicity categories, the earned GPA of Passport transfers was higher than those who earned a Passport and didn't



transfer (but not significant). Overall trends for the WICHE Passport program have been remarkably stable across the history of the program, even while the composition of reporting institutions (four-year vs. two-year and reporting by different states) has changed.

This stability may be attributed to the GPA requirement built into the Interstate Passport® program. Students earned Passports by meeting a GPA requirement in all Passport Block coursework. This GPA requirement was established as an important mark of quality assurance for the program to ensure transfer-level proficiency. Throughout the tenure of the Interstate Passport® program, "transfer-level"

proficiency" was defined as a minimum grade of "C" or its equivalent in all Passport Block courses to earn a Passport, letter grades being a mutually intelligible and easily traceable metric by which to understand student success. Because of the GPA requirement to earn a Passport, it may not be surprising that GPA outcomes for students who had earned a Passport were better than GPA outcomes for those students who had not earned a Passport. As a result of this grade requirement, academic progress tracking doesn't provide as much information as may have been intended in the design of the program, particularly in the comparison of Passport-earning students to non-Passportearning students at Passport institutions.

Interstate Passport® reporting included data around the average number of student credit hours earned in an academic year. The number of credit hours sustained between Passport Transfers, Non-Passport Transfers, and Non-Transfer Passport Earners fluctuate throughout reported years with students who earned a Passport (regardless of if they transferred with the Passport or not) generally earning more credit hours than those students who did not earn a Passport. Data on how students who did not earn a Passport and did not transfer were not collected, so no comparison can be made to understand how earning a Passport impacted non-transfer students.

WICHE has no data around how those credits were accepted at the receiving institution.

A design feature of the Passport was that it addressed only lower-division general education


(LDGE), the rationale being that the LDGE was the most consistent offering across all institutions and the LDGF serves as the base upon which academic programs are built. This design and assumption did not endeavor to address questions around degree requirements, major prerequisites, or elective credits. Through research at the Community College Research Center (CCRC),1 we know that the overall total number of credits taken by transfer students (taken at the two- and four-year institution) tally above and beyond the number required for the student's bachelor's degree program (typically 120 semester credits). This outcome is particularly pronounced in fields that demand curricular complexity, such as Engineering disciplines.² This surplus of credits can lead to challenges with financial aid and is antithetical to the stated goal of saving students time and money in their pursuit of higher education.

The number of students who transferred after earning a Passport lagged the overall number of Passports awarded. Because students did not need opt-in to their Passport, rather, the Passport was automatically awarded to all students who had met the criteria, it follows that many students who did not intend to transfer earned their Passport. However, is notable how few students leveraged Passport as designed. According to the NSC, transfer enrollment represents 13.2% of all continuing and returning undergraduates for fall of 2023. ³ While these data fluctuate across all years of the Interstate Passport® project, it is notable that only 1.7% of Passport earners leveraged their Passport for transfer within the Interstate Passport® Network over the life of the project.

Interstate Passport® institutions were encouraged to leverage the Passport as a goalpost credential that signaled students who had successfully completed their general education, so it is possible that even those students who did not use their Passport to transfer were still aware of the impact of Passport on their progress. Overall, there was no ongoing student feedback mechanism in the design of Interstate Passport®, so no conclusions can be drawn regarding how strategically students were or were not leveraging the Passport for transfer success. The disconnect from the end user of the Interstate Passport® program limits our understanding of the success of the program.

Growth of the Interstate Passport® Network Over Time



In its seventh year of full implementation, Interstate Passport® had seen stagnation in the growth of the network. At the end of the 2023 fiscal year, the network had 67 member institutions spanning 21 states, including all public two- and four-year institutions in four of those states (at the end of fiscal year 2023, the network included all public two- and four-year institutions in Alaska, Hawai'i, South Dakota, and Utah). Over the life of Interstate Passport®, WICHE saw two years of significant enrollment into the Network, responsive to grant-affiliated campaigns. However, in the final grant period, WICHE saw a slowdown in organic interest, growing reluctance to engage with the project, and institutions electing to leave the network, even before their waived membership fee window had closed.

In the summer of 2022, WICHE staff contracted with an independent communications and marketing firm, Philosophy Communications, to conduct focus groups of existing and prospective member institutions with the goal of refining WICHE's messaging for our desired audience and updating older collateral with this messaging. Four focus groups were conducted; two focus groups of existing members of the Interstate Passport® Network, and two focus groups of prospective institutions for a total of 17 individuals surveyed. What we learned was that for existing members, there were many concerns that even though the program had been implemented, the data for student outcomes was either nonexistent or insufficient to understand if their investment of staff labor had paid off.

For prospective members, we learned that our recruitment and marketing efforts were good at presenting the program in a positive light, but there was no sense of urgency in joining the network. Institutions in states where there were government mandates around transfer and articulation between public institutions saw Interstate Passport® as a competing, rather than complimentary initiative due to the labor demands of aligning their institution with either initiative. In 2022, 38 states had policies requiring a transferable core of lower-division courses: within the WICHE region, 14 of the 16 states and freely associated territories have policies requiring a transferable core of lower-division courses.4 Broadly, both existing and prospective institutions cited concerns about the amount of staff labor required to map PLOs on their general education coursework and to meet reporting requirements.

AY 2022-23 Impact

REPORTED PASSPORTS EARNED

For the 2022-23 academic year (October 1, 2022-September 30, 2023), 29 institutions reported awarding Passports. Network members reported 16,441 Passport awards in the academic year, which compares to 19,205 reported in AY 2021-22 (with 30 total institutions reporting that year). Although the total number of reported awards declined, the number of Passports awarded by two-year schools increased by 34% to 6,166 in AY 2022-23 (vs. 4,608 in AY 2021-22). This increase accrues after the number of two-year awards more than doubled in the prior year. Academic Progress Tracking reported 329 Passport transfers between participating institutions. The AY 2022-23 additions increase the total number of reported Passport awards to 105,010.

ACADEMIC PROGRESS TRACKING

For the 329 students who transferred with a Passport in AY2022-23, weighted average GPA was 3.46. This compares to a GPA of 3.04 for students who transferred without a Passport, and a GPA of 3.47 for students who earned a Passport while remaining at the same institution. Average GPA for Passport transfers is higher than the prior year, and similar to the average for the last several years. In addition, the pattern of results (students transferring with a Passport earning a higher average GPA than non-Passport transfers in the terms immediately post-transfer and earning similar GPA to students who earn a Passport and remain at their home institution) remains consistent across all reported dimensions. GPA for Passport transfer students (after transfer) was consistently higher when compared to students who transferred without a Passport in the same cohorts, irrespective of Race/Ethnicity, Gender, Age, Low Income (Pell), Military Veteran, or First-Generation Student status, for all measurable sub-groups with significant sample size.

Partnerships and Activities

JULY 2022

WICHE staff contracted with an independent communications and marketing firm, Philosophy Communications, to conduct focus groups of existing and prospective member institutions with the goal of refining WICHE's messaging for prospective Interstate Passport® Network members.

SEPTEMBER 2022

WICHE staff convened with other participants in ECMC Foundation's <u>Catalyzing Transfer</u> Initiative (CTI) community of practice in Denver, CO, for a two-day workshop. The Catalyzing Transfer Initiative provided \$4.5 million to five organizations working to increase successful transfer of postsecondary credits and timely bachelor's degree completion through equity-centered projects. Each grantee gave updates and discussed challenges with their project and participants left the workshop with actionable steps for the remainder of their grant period.

JANUARY 2023

WICHE staff attended and presented a poster session at the 2023 American Association of Colleges & Universities (AAC&U) Conference on General Education, Pedagogy, and Assessment with input from Truckee Meadows Community College (TMCC). The poster was titled "The Work is Already. Being Done: Uncovering Opportunities for Assessment" and explored the way that PLOs can be leveraged for accreditation-related assessment needs.

FEBRUARY 2023

WICHE staff attended and presented at the 2023 National Institute for the Study of Transfer Students (NISTS) conference. The session titled "Lessons Learned: Interstate Passport® after Five Years of Implementation," focused around assessing mature and maturing programs, ways to maintain enthusiasm and concern for the program despite stakeholder turnover, and strategies for interrogating programs to ascertain if they are delivering on their original project goals.

MARCH 2023

WICHE staff convened the Passport Review

Board for the annual review of the progress and success of Interstate Passport®. Because of the pivotal timing coinciding with the end of the ECMC Foundation grant period, the decision was made to meet twice — once to evaluate the activities. budget, NSC data, and recruitment efforts, and again to vote on the best use of remaining budget. Between meetings, current members of the Interstate Passport® Network were polled to better understand their perception of the costvalue benefit of continued participation in the network, and overall likelihood of institutional leadership's willingness to pay membership dues for continued participation in the network. The decision was made to produce a resource repository on the WICHE website.

APRIL 2023

WICHE staff attended and presented at the 2023 Higher Learning Commission Annual Conference in partnership with representatives from Laramie County Community College and the New Mexico Higher Education Department. The session was named "Improving Credit Transfer and Exploration of the WICHE Interstate Passport®."

MAY 2023

The WICHE Commission was notified of the outcome of the Passport Review Board meetings. WICHE staff engaged in outreach efforts to the chief academic officers, institutional liaisons, and registrars at Interstate Passport® Network institutions to communicate the news that WICHE will no longer oversee the management of the Interstate Passport® Network and provided the recommended next steps.

JUNE 2023

WICHE finalized participation in ECMC Foundation's <u>Catalyzing Transfer Initiative</u> by submitting a final report.

WICHE published a <u>press release</u> with the information around sunsetting Interstate
Passport® and held a virtual open forum for stakeholders to ask questions. WICHE staff met with Network members throughout the summer to address concerns, questions, and field requests for needed resources.

AUGUST 2023

Interstate Passport® Network institutions reported their final dataset to the NSC. Member profiles were migrated to the WICHE website.

SEPTEMBER 2023

A working group comprised of former Passport Review Board members, faculty, and advisors gathered to produce a general use articulation agreement. An articulation agreement is a legal document used to facilitate the transfer of credits between institutions of higher education. The articulation agreement developed by this working group allows institutions that wish to use the principles and tools of the Interstate Passport® program to establish transfer relationships to formalize their agreement.

WICHE staff coordinated the termination of the existing contract with the NSC.

OCTOBER 2023

Existing Interstate Passport® collateral was evaluated by WICHE staff for revision and migration to an online repository.

NOVEMBER 2023

WICHE staff attended and presented at the 2023 U.S. Department of Education Raise the Bar Transfer Summit. The session was called "Creating Effective Transfer Partnerships" and was presented in partnership with colleagues at the New England Board of Higher Education (NEBHE) and the Florida Consortium of Metropolitan Research Universities.

DECEMBER 2023

The general education block transfer articulation working group finalized a draft of the proposed general use articulation agreement.

JANUARY 2024

WICHE published an Interstate Passport® webpage which includes resources, example member profiles, and working articulation agreement for use by any institution. Visit wiche. edu/interstate-passport.
