- ✓ Integrated education and training (IET) programs combine adult education and literacy activities with workforce preparation and training.
- ✓ By integrating these three components, IET programs can accelerate learning and support adult learners as they advance along their career pathways, transitioning to postsecondary education and obtaining good jobs.

History of Integrated Education and Training (IET) in Nevada:

- Some bridge classes existed prior to 2017, but no full “IET”
- NSHE policy change 2017
- IET/IELCE pilot project SFY 2017-2018
- As of July 2024, our office is requiring applications for all IET and work-based projects and is collecting a repository of approved applications

Future of Nevada IET:

- Funding incentives
- Roll out of pre-approved statewide IETs
- For the next competition cycle, IET will be considered in the funding formula (tbd)

Challenges:

- Funding for occupational training (restrictions)
- Getting buy-in from occupational training providers
- Tracking of the IET program offerings

Co-enrollment & Regional Career Navigators


Career Coaching within K-12, Postsecondary & the Workforce System Differs

Regional Career Navigators encompass a holistic approach to coaching:

- 1) Knowledge of LMI, industries & jobs, and occupational demand
- 2) Knowledge of postsecondary pathways (adult education, noncredit, credit)
- 3) Knowledge of WIOA wrap-around supports (co-enrollment requirements)
- 4) Application of human-centered design (rural, adult context)

Co-enrollment with WIOA, Title II/Adult Education, and Postsecondary engages a comprehensive model to support rural learner success!
